2. Declarations of interest received in writing:

Cllrs. K. G. Burnell and H. J. David declared an interest in all matters concerning the Cefn Cribwr Gardening Club as members of that organisation.

3. Minutes:

4. Matters arising:

School Crossing Patrol Officer: Cllr. H. J. David reported that this position has been advertised twice but, to date, no applications have been received. It is hoped this vital job in our community will be filled soon.

War Memorial: The Clerk reported that work at the War Memorial had been completed and all who had seen it agreed it is looking very good.

Community Apple Trees: The Clerk reported that Mr. S. Powell of CCAC had kindly agreed to plant 20 trees at Cae Gof, having checked with BCBC this would be permissible under the terms of their lease. However, all the trees have been allocated for this year. It is hoped that we will be successful next year if we apply as soon as applications open.

5. Footpaths:

Footpath 40 Dale View to John Street: The Clerk reported he had received notice from BCBC of the Definitive Map Modification Order – Addition of footpath leading from Dale View to FP 40. The closing date for objections or representations is 13th March 2025

Footpath 23 – The Clerk reported that he had received no response from BCBC rights of way dept about the fly tipping along this footpath at its southern end. Cllr. H J. David kindly agreed to follow this up with the rights of way dept.

Refusals:

<u>P/24/429/FUL</u> Mr H Murray, 2 Pleasant View: Remove existing single-storey rear extension's mono-pitch roof and erect a new first floor double-pitch roof extension over part of the existing single storey rear extension to incorporate additional and amended internal accommodation arrangements.

<u>P/24/403/FUL</u> Clanfield, Rear garden area of Windcroft Cefn Road: Proposed three-bedroom bungalow with access from Cwm Ffoes and associated works.

7. Community Grant Application:

Council considered an application from Forces Fitness Education CIC for a grant of £500 to run a Children's Health & Well Being day, similar to those they have operated from Bridgend and Cowbridge Town Councils. Members were interested in the proposal but felt they needed more information before reaching a decision. It was agreed the Clerk would invite a representative of the organisation to attend a future meeting to discuss the application in more detail.

8. Members Report:

Princes of Wales Hospital: Cllr. H. J. David reported that maternity and neonatal services will be returning to Princess of Wales Hospital over the coming weeks. The temporary closure of maternity and neonatal units began in September 2024 to enable Cwm Taf Morgannwg University Health Board to carry out essential maintenance work. In addition to this work, a large-scale estates project to replace the roof of the main body of the hospital is also ongoing. The improvement work to the maternity and neonatal units, and the roof over that area of the hospital, have now been completed.

Porthcawl Regeneration: Cllr. H. J. Davied reported that the next phase of Porthcawl's ongoing multi-million-pound regeneration scheme featuring the publication of a masterplan outlining how the waterfront area could be developed and used in future. It also forms the basis of a new dedicated website, <u>porthcawlwaterfront.co.uk</u>, developed jointly between Bridgend County Borough Council and Welsh Government, the exhibition has been organized as part of an overall three-week consultation.

Grand Pavillion, Porthcawl: Cllr. H. J. David reported that new information panels about the Pavillion's redevelopment have recently been installed outside. Inside, further enabling works by Bridgend County Borough Council are continuing and the main construction works are currently going through a procurement process.

Mynydd Cynffig Primary School: Cllr. H. J. David reported that plans for a new-build replacement for Mynydd Cynffig Primary School by Bridgend County Borough Council are continuing to progress with a full planning application now having been submitted for consideration.

Chris Elmore MP: Cllr. H. J. David reported that he and Cllr Gebbie will be joining Chris Elmore MP for his next advice surgery at Cefn Cribwr Community Centre on Friday 14th February.

BT Openreach: Cllr. H. J. David reported that following an email from a local resident he had written to Chris Elmore MP on 20th January asking if he could seek an update from Openreach on improvements to broadband in Cefn Cribwr. We await a response in due course.

Warm Hub at Community Center: Cllr. H. J. David reported that he had successfully applied for funding for the Community Association for Welsh Government funding from the BCBC via BAVO for free teas, coffees and soups at the warm hub that runs alongside the community pantry at the Community Center every Tuesday at 12.30-2.00pm. *Road defects:* Cllr. H. J. David reported that several defects on New Road from Derllwyn Hill to Craig Yr Aber woods have been identified and an order has been issued for their repair.

Road surface at Ty Isaf: Cllr H. J. David reported that he and Cllr Gebbie had met on site at the bottom of Ty Isaf with local residents about the condition of the carriageway. Cllr Gebbie had taken photos and a video and has asked BCBC Highways Dept for update. White marks have subsequently been painted on the carriageway which indicates repairs will be carried out.

Temporary traffic lights: Cllr H. J. David reported that temporary traffic lights had been installed on Cefn Road to enable works by Welsh Water Dwr Cymru.

Pedestrian Crossing at Mynydd Back Common: Cllr H. J. David reported that a request had been received for a safe crossing at Sea View to the Common. Cllr Gebbie was making enquiries.

Micro Nuclear Energy Plant: Cllr H. J. David reported that the next public consultation on a proposal to build four 20 MW micro-nuclear energy plants on the site of the former coal-fired power station at the Llynfi river, Llangynwyd will be on Monday 17th February from 6.15pm to 9pm at Coytrahen Community Centre in Coytrahen.

Mynydd Y Gaer Wind Farm: Cllr H. J. David reported that Cennin have started pre application consultation (PAC) on the Mynydd Y Gaer Wind energy development as part of the Bridgend Energy Hub.

Mynydd Ty-Talwyn Energy Park: Cllr H. J. David reported that this application has been deemed a Development of National Significance, therefore the application that will be considered by Welsh Government not Bridgend County Borough Council the local planning authority. BCBC will be required to provide a Local Impact Report including regarding noise and the landscape/visual impact of the development once the application has been lodged with PEDW. *Former Reservoir site:* Cllr H. J. David reported that the agent for Valleys to Coast, the developer of the former reservoir site, is working to discharge the planning conditions attached to the planning permission.

Scrambling at former Opencast: Cllr H. J. David reported that Pyle Neighborhood Policing Team (NPT) have received a very low number of reported occurrences of off-road motor scrambling on the former Margam Mine Opencast. Residents were encouraged to report any problems of annoyance to enable more action by South Wales Police and partners.

PACT: Cllr H. J. David reported that South Wales Police's next PACT meeting is on 20th February at Pyle Life Centre.

For what purpose do you require funding? - We aim to use our Military Veteran Role Models to bring the children from our community together to conduct a Health and well-being day that will concentrate on Building Resilience, working on communication and team building challenges for children and young adults in the Cefn Cribwr Community Council ward. Delivery of the health; Well-Being and Building resilience sessions that will take place at a location central to Cefn Cribwr Community Council ward residents. Engaging schools, Youth groups, sports clubs and community organisations in Cefn Cribwr . Beneficiaries will be aged between 7-25 years of age. We will utilize social media to engage with stakeholders and our extensive database of contacts from previous programs within schools; community groups and sports clubs. On all sessions that are delivered we will ensure that feedback forms are conducted to gage learner feedback from the young attendees through their own learners voice; this will be conducted through a google form link; we will also ask the parents/ carers to complete a feedback form; all this information will be collated after each session delivered. We have delivered similar projects in partnership with a number of community councils in 2024 including Bridgend Town Council, Cowbridge Town council and Coity Higher Community Council with fantastic results. 

This report is an overview from the Forces Fitness Education CIC Funded sessions who were consulted after attending the free to attend Health, Well-being and Building resilience sessions that were run in October Half Term.

45 Children attended; 12 Adults were also present during the sessions.

From all the people who attended our sessions the people rated the sessions Between Very Good and Excellent sat at **4.83** out of 5. **Scale 1 = Poor, 2=OK, 3=Good, 4= Very Good, 5 = Excellent**

We had a 100% response from the 57 people engaged that they would like to take part in similar activities again.

The Attendees of our sessions the people rated the Instructors Between Very Good and Excellent sat at **4.92** out of **5**. Scale **1** = Poor, **2**=OK, **3**=Good, **4**= Very Good, **5** = **Excellent**

100% of attendees said they had fun on the previous sessions we've delivered.

REVIEW OF THE COMMUNITY ARRANGEMENTS OF THE COUNTY OF BRIDGEND

Cefn Cribwr is a unique settlement within Bridgend County Borough, with a long and well recorded history that stretches back further than that of Kenfig Hill and Pyle to the Iron Age. The settlement itself is well served with an oversubscribed Primary School; Community Centre; Shops; Garage; Community Pub; Athletic Club; Sports & Social Club; playing fields which include sports pitches, bowling green and multipurpose all weather sport courts; five places of worship; Community Association; Community Pantry; Labour Party Branch; Y Cefn Gwyrdd local history society; Gardening Club; etc. All of which demonstrate a cohesive and integrated multi-generational community. Of course, we acknowledge there are links with our neighbouring communities, but there are clear geographic and topographical differences which make any meaningful integration, and therefore community cohesion, which surely is the fundamental point of any democratic society, not to mention the purpose of Town and Community Councils, unachievable.

We reject the assumption that having a bigger community council will be more efficient or effective. Our track record of community engagement and bringing large scale projects, which benefit the community to fruition, working in partnership with BCBC and local organisations, is clear for all to see.

We do not agree with the assumption that an uncontested election must be undemocratic, and/or indicates there is no support for the body – this is not a sign of failure. We believe, given the comments we receive, that in this instance it is a sign of contentment and support. Therefore, we do not except the premiss that for a community council of our size an uncontested election reflects a democratic deficit. On the contrary, there is an inherent risk by creating large town and community councils, with no logical geographical relationships, that the voice of smaller and distinct communities like Cefn Cribwr will not be heard nor their local needs meet when there are a vastly greater number of voters in the other communities. This view having been expressed to us by several member of our community.

We note that the current proposals would mean that the new Community Council would straddle two democratic boundaries: Cefn Cribwr is in the Bridgend & Porthcawl Parliamentary Constituency, whereas Pyle and Kenfig Hill are in the Aberavon & Maesteg Constituency. Cefn Cribwr is in the Bridgend and Vale of Glamorgan Welsh Government Constituency whilst Pyle and Kenfig Hill are in the Aberavon Rhondda and Ogmore Welsh Government Constituency. We are at a loss to comprehend why anyone would think this arrangement would provide convenient or effective representation or communication and hold the views this would only lead to more confusion.

We already share three Bridgend County Borough Members; the loss of an individual member has increased the risk and anxiety that in the future our unique voice will be lost as there will be no body or individual dedicated solely to representing the views of the contained village of Cefn Cribwr.

We note the proposal that Cefn Cribwr would only have 2 members representing them on the newly formed Community Council. We are very concerned that this is unrealistic given the workload required to represent a busy and vibrant community, which is currently served by ten members and a dedicated Clerk and believe this would not be sustainable. Furthermore, we do not agree that electing members to a Community Council based purely on a misjudged obsession with electoral parity benefits our community as it reduces their representation by approximately 90% when you take into account the proposed number of Members and the huge increase in population. We are therefore confident that no one would consider the proposed arrangements to be an improvement and legitimately believe that a community such as ours deserves far greater representation than is proposed.

We would like to see evidence of a proper and effective public consultation. The subject heading for the draft proposals - REVIEW OF THE COMMUNITY ARRANGEMENTS OF THE COUNTY OF BRIDGEND - does not describe accurately or in enough detail the impact of the proposals. We do not believe that a broad-brush generic consultation is good enough to capture accurately the views of residents.

Fundamentally, we believe these proposals, should they be ratified are an attack on grass roots democracy because they would inevitability dilute the local voice. Therefore, we call upon the Members of Bridgend County Borough Council to reject these proposals.
